NPCC provides insurance coverage for artworks while on display in the Main Gallery and Hall Gallery subject to a maximum of \$3000 per work and total \$50,000 per occurrence. Accidental breakage of glass or other fragile article damage is not covered. Additional coverage and coverage for works in transit is the responsibility of the artist. Any insurance claims must be made before artwork is removed from the Gallery. Valuation is based on cost of replacement of materials or proof of the sales of comparable works in the last 24 months.

PICK UP AT CLOSE OF SHOW

Please arrange for pick up from Neilson Park **Sunday, March 4, 2012, between 4:00 p.m. and 5:00 p.m.** Neilson Park Creative Centre will not be responsible for works left at the Centre after this time since storage space is not available and insurance coverage terminates at the end of the show.

Work not picked up will be removed by the EAG Board of Directors (416 695 4378) which will not be responsible for damage or loss of the work. The artist will be charged a \$15.00 transport and storage fee .

LABELS

The artwork must have two labels; a **back label** affixed to the back lower **left** corner of the work, the **front label** affixed to the top **right** corner. 3D work should have the back label securely fastened, out of sight when placed on display.

SALES OF ART

Works may be paid for by cash, cheque, debit, VISA or MasterCard. HST will be applicable to all sales.

Artists will be notified when a work is sold and will receive payment for all sold work within 14 days of the end of the show, less a 10% commission. HST will be remitted to all artists on submission of their HST registration number, otherwise HST will be reported and remitted by NPCC.

Artworks may not be removed before the closing date and time.

Artists will be responsible for delivery of artwork to the purchaser following the exhibition.

TERMS FOR ACCEPTING ART

Submitted works must be wired and ready to hang.

Wet paintings, faulty wires and insecure framing will not be accepted.

Paintings and photographs must have frames with rings or screw eyes on both sides at the back, placed no lower than 6 inches from the top so that the picture will not lean forward from the wall.

Wire must be appropriate for the weight of the artwork and its hung position must be 3 inches from the top of the frame so that the hanging hook will not be visible.

Fibre art must have a 4 inch pocket/sleeve sewn to the back with a rod or dowel to extend 1 inch on either side of the piece.

A limited number of stands are available for sculptures.
